EVICTION WORKSHOP – Provides an overview of the eviction process for Landlords. Instruction regarding document preparation is available.

COLLECTIONS – Mandatory Settlement Conf. Workshop (MSC) - Parties in most debt collection cases are required to discuss settlement in a Mandatory Settlement Conference (MSC) or mediation before trial. This workshop explains debt collection settlements and helps with the required forms. Self-represented parties are strongly encouraged to attend this workshop at least one week before their MSC or trial date.
