**EVICITION WORKSHOP** – Provides an overview of the eviction process for Landlords. Instruction regarding document preparation is available.

**TLAP –TENANT/LANDLORD ASSISTANT PROJECT**  
Provides advice/assistance to qualified applicants in Unlawful Detainer (eviction) cases.

**BCAP – BANNING COURT ACCESS PROJECT**  
Provides advice/assistance to qualified applicants in Civil matters. Bilingual assistance is available.



**CIVIL SELF-HELP** – Provides legal info/assistance to self-represented litigants in: unlawful detainer (**landlord and tenant**), small claims, limited civil, & basic probate matters. Sign-ups begin promptly at 7:30 am. The program is on a first come, first serve basis.

**SMALL CLAIMS WORKSHOP** – Provides an overview of the Small Claims Process. Document preparation is provided.

**COLLECTIONS – Mandatory Settlement Conf. Workshop (MSC)** - Parties in most debt collection cases are required to discuss settlement in a Mandatory Settlement Conference (MSC) or mediation before trial. This workshop explains debt collection settlements and helps with the required forms. Self-represented parties are strongly encouraged to attend this workshop at least one week before their MSC or trial date.
